<b>15-Aug</b>	<b>Mail Registration for Primary</b> Last day to postmark application for Primary and the last day application is to be received by Board of Elections is August 21, 2015. §5-210(3)	<b>9-Oct</b>	<b>Mail Registration for General:</b> Last day to postmark application for General Election and last day it must be received by Board of Elections by Oct.14, 2015. § 5-210(3)
<b>16-Aug</b>	<b>In Person Registration for Primary</b> Last day application must be received by Board of Elections to be eligible to vote in Primary Election. §§5-210, 5-211, 5-212 (Due to change of Primary Date)	<b>9-Oct</b>	<b>In Person Registration for General:</b> Last day application must be received by Board of Elections to be eligible to vote in General Election. If honorably discharged from the military or have become a naturalized citizen since October 9th, you may register in person at the Board up to Oct 24, 2015. §§5-210,5-211, 5-212
<b>21-Aug</b>	<b>Changes of Address</b> for Primary received by this date must be processed. §5-208(3)

<b>9-Sep</b>	Last day to postmark ballot. Must be received by the County Board no later than Sept 17, 2015. §8-412(1)	<b>2-Nov</b>	Last day to postmark General Election ballot. Must be received by the County Board no later than Nov 10, 2015. §8-412(1)
<b>10-Sep</b>	Last day to deliver Primary ballot in person to County Board, by close of polls. §8-412(1)	<b>3-Nov</b>	Last day to deliver General Election ballot in person to County Board, by close of polls on Election Day. §8-412(1)

<b>9-Sep</b>	Last day to apply personally for Military ballot for Primary if previously registered. §10-106(5)	<b>2-Nov</b>	Last day to postmark Military/Special Federal ballot and date it must be received by Board of Elections is Nov 16, 2015. §10-114(1) §11-212
